# Business License Procedures Home Occupations (Level I and Level II)

#### **Application Procedures**

All forms are available at <a href="https://mendoncityutah.gov">https://mendoncityutah.gov</a> or by emailing the City Clerk at <a href="mailto:cityclerk@mendoncityutah.gov">cityclerk@mendoncityutah.gov</a>. New applications and renewal applications can be submitted by one of the following methods:

- Mail: Mendon City Clerk, P.O. Box 70, Mendon, UT 84325
- **Drop box:** Place payment and completed application in a sealed envelope clearly labeled Attn: City Clerk. The drop box is located on the south side of the parking lot at the City Offices.
- In person: Bring into the Mendon City Offices during business hours.

See Zoning Ordinance Section 3.36 for home occupation classifications.

#### **NEW** Home Occupation Business License Applications:

Submit a completed Home Occupation Business License Application/Renewal Form and appropriate fee (see below).

#### **RENEWAL** Home Occupation Business Licenses:

Submit a completed Home Occupation Business License Application/Renewal Form and appropriate fee (see below).

#### Level I – Home Occupation

Submit a completed Home Occupation Business License Application/Renewal Form and appropriate fee (see below). If the home occupation is a daycare/preschool, a fire inspection is required (with an additional fee).

#### Level II – Home Occupation

Submit a completed Home Occupation Business License Application/Renewal Form and appropriate fee (see below).

#### **Fees**

- Level I Home Occupation: \$10 annual license fee.
  - NOTE: All daycare and preschool providers are required to obtain a fire inspection upon new start-up with an additional \$40 fire inspection fee. (Please include this amount with your license fee.)
- Level II Home Occupation: \$25 annual license fee.
  - \$40 mandatory fire inspection fee upon new start-up. (Please include this amount with your license fee.)
  - NOTE: Additional fees may apply for Level II Home Occupations as Conditional Use Permits may be required.

### Business licenses are due for renewal each fiscal year throughout the month of June.

There will be a late fee of \$25 for all renewals received after July 1.
